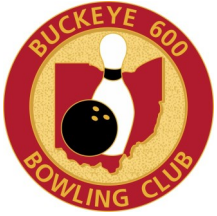

**Annual Meeting, June 27th after last squad is finished**  
**Roll Off Sunday, June 27th 8:00 am**

1. The tournament will be held at Legacy Lanes & Lounge, 775 South 2nd Street, Coshocton, OH. Squads are June 19 at 2:00 pm, June 20 at 11:00 am, June 26 at 10:00 am and June 27 at 12:00 pm. Entries close May 31, 2021. All entries postmarked the first business day following the entry closure date will be accepted. No refunds will be issued.
2. This is a singles tournament with highest three game total with handicap being the winner. After closing date, walk-ins will be accepted one (1) hour before squad time and depending on lane availability. WALK-IN FEE \$5.00.
3. Entry fee is \$28.00 (Prize fund \$14.00; Bowling \$9.00, Expenses \$5.00). Buckeye Bowling dues of \$2.00 (if not paid at the 2019 District Tournament) must be included with the entry fee. Personal checks will be accepted. Optional Actual Division is \$5.00 (Prize Fund \$4.00; Expenses \$1.00). \$35.00 SERVICE FEE WILL BE CHARGED FOR CHECKS RETURNED BY THE BANK.
4. Prize Fund supplemented by the Buckeye 600 Bowling Club.
5. This tournament is USBC certified, open to all females who are members of the Ohio State USBC and National 600 Club. All prize fees will be returned 100% with at least one prize for every five entries. An award will be presented to the winner by the Buckeye 600 Bowling Club.
6. HANDICAP: 90% based on 225 average.
7. Highest final 2019/20 USBC certified league average for 21 games or more (winter or summer). If no 2019/20 average, 2018/19 average, 21 games or more (winter or summer). If neither of these, current season average 12 games or more as of entry closing date. Current average must be verified in writing by league secretary. If no average meets these requirements, you must bowl scratch. Averages will be verified through Bowl.com. Prize money will be issued based on the verified average. Corrections in average may be made up to the completion of the first game of the series. USBC rule 319A-2, 319C, 319D and 319E will not apply.
8. The entrant whose name appears, or their authorized replacement, hereby agrees the Buckeye 600, its officers and agents, shall be liable only to the extent of returning entry fees if and when those entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary scheduled changes, or premature termination of the tournament that may be brought about by war, national emergency, or by causes relating thereto or resulting therefrom fires, strikes and lockouts or labor difficulties beyond the control of Buckeye 600 Club.
9. NO OPEN BOWLING BY ANY PARTICIPANT ON THE TOURNAMENT LANES ON ANY DAY OF THE TOURNAMENT WILL BE PERMITTED.
10. In case of a tie, co-champions will be declared.
11. **PLEASE CHECK IN NO EARLIER THAN ONE (1) HOUR PRIOR TO YOUR SCHEDULED TIME TO BOWL.**
12. **Proper attire required (no spaghetti straps, midriff baring tops, short shorts/skirts, low rider pants, see-through clothing, etc.). Failure to follow this rule may result in disqualification.**
13. **Disruptive and/or unsportsmanlike conduct, profane language and obscene gestures will NOT BE TOLERATED. After the first warning, you will be disqualified from the tournament and no monies will be refunded.**
